BRACKENRIDGE PARK TREE REMOVAL POSTPONED

A Parks Dept. plan to cut down 104 trees has been postponed – most likely until this fall. As part of a 2017 bond issue project to restore historic stone walls and structures alongside the river in Brackenridge Park, the Parks Dept. proposed removing the trees to protect the structures and ensure public safety. The fact that 10 heritage trees (with trunk diameter of 24" or greater) were part of the removal plan created attention, consternation, and gnashing of teeth. Also concerning was the fact the frequently disregarded, City Council-approved tree ordinance includes a 100% prohibition on removing heritage trees.

Heritage trees are considered irreplaceable because of their age, rarity, or size. The 10 heritage trees proposed for removal included live oak, pecan, and bald cypress. The Parks Dept. proposed to plant at least 200 replacement trees in the area, as well as 200-400 replacement trees elsewhere in the park.

YOUR TAX \$\$\$ AT WORK, PART 2,102,077,278

Our District 2 City Councilman Jalen McKee-Rodriguez recently initiated efforts to introduce several items for consideration by the City Council. Of particular interest to residential neighborhoods inside Loop 410 is his proposal to require displacement studies to "proactively mitigate the impacts of displacement prior to incentivizing or approving development contracts."

A CURIOUS POLITICAL OCCURRENCE

Observant neighbors were surprised to see a campaign sign displayed on the SA Botanical Garden's property near Pershing Avenue & Old Austin Road. The large, red, 4' x 4' sign for a Bexar County Republican Chairman candidate was securely attached to posts that previously held a Botanical Garden sign and later a sign for the café operator in the Sullivan Carriage House. NOTE: The candidate received 45% of the vote in the GOP primary.

S.A. POLICE DEPARTMENT REPORT

Officer Juan Hernandez patrols our neighborhood and reported for the period between January 1 and February 15, one aggravated assault with a deadly weapon occurred, which involved an officer who was not injured.

Officer Hernandez also reported homelessness remains an ongoing issue within Mahncke Park and surrounding areas. Encampment abatements are slowly ramping up. However, the biggest challenge is convincing homeless individuals to accept available resources such as housing via Haven For Hope. Therefore, when abatement of an encampment occurs, the residents scatter temporarily then build another camp elsewhere. For example, there was a large encampment along the San Antonio River in the River Road neighborhood. Eventually, the encampment was abated and dismantled. The individuals were later found in an encampment near Highway 281 and Mulberry Avenue. The same thing occurred with encampments under the IH-35 corridor. Despite these challenges, SAPD, Park Police and the City's Department of Human Services will continue to offer services with the hope that homeless persons gain the help they need - but the city will also implement and enforce laws to alleviate issues within neighborhoods.

SOME RESULTS FROM 2020 CENSUS

The 2020 census is starting to provide an interesting view of changes in the San Antonio population. Tract 1920, which includes Mahncke Park, the SW corner of Terrell Hills, parts of Fort Sam Houston, the area slightly north of Incarnate Word, and property between Broadway and the S.A. River south to IH-35 is one of the few portions of town where the Hispanic population went down (5.2%) and the White population went up (4.1%). [We're using the language of the census report.] The number of people listed as two-or-more races more than doubled.

By contrast, in San Antonio as a whole, the Hispanic population increased .7%, as the White population fell by 3.2%. Again, people identifying as bi-racial more than doubled. Gary Cox of Pershing Avenue reports the Parks Department is scheduled to complete repairs this month to lights in the Mahncke Park fountain. The fountain is located in the park near Broadway and was a gift to the city from Ludwig Mahncke's daughter, Mrs. Joseph Mahncke Deutz, in 1964 in memory of her father, who was San Antonio's first Parks Commissioner from 1896 until 1906.
