

# ZONING BOARD OF ADJUSTMENT: 115 MILTON ST.

The property owner of 115 Milton Street has requested multiple variances from the City's Zoning Board of Adjustment. The issue involves the new three story, 2-unit residence under construction on the west side of Milton St. between Claremont Ave. and Natalen St. The property was originally part of the lot at 154 Claremont. The owner re-platted the property to create a separate lot (115 Milton St.) from the rear portion of 154 Claremont.

The owner is requesting variances to the following Mahncke Park Neighborhood Conservation District standards:

- 1. 15' limit to width of curb cuts for driveways,
- 2. Limit of one curb cut per 50' of lot frontage,
- 3. Requirement to provide parking for 2 cars for each dwelling unit,
- 4. Requirement for 4' separation of sidewalk from driveway.

If approved, the variances would allow head-in parking for 4 cars in front of the Milton St. structure.

The MPNA Land Use Committee (LUC) met with the property owner on July 18, 2023. Following its meeting, the LUC recommended the MPNA Board of Directors object to each of the requested variances. The MPNA Board voted to object. The variance requests will be considered by the Board of Adjustment on August 7, 2023 in the City's Development & Business Services Center at 1901 S. Alamo St., beginning at 1pm.

## YOUR TAX \$\$\$ AT WORK, PART 2,103,812,088

Broadway Street construction between downtown (Houston Street) and the IH35 overpass continues. The following status report was prepared by the Public Works Dept. and forwarded by the City Council District 2 Office:

Contractor Sundt Construction continues roadway reconstruction on the Broadway Corridor Lower Segment (E. Houston St. to IH-35) Project and bike lane work on the Avenue B and N. Alamo Street Bike Lane Project.

- Broadway & E. Jones Intersection.
   The intersection is opened to northbound and southbound traffic. Eastbound and westbound traffic remains closed through August 2023 for CPS electrical overhead to underground conversion.
- Broadway (Brooklyn to Roy Smith).
   Through August 2023, westside roadway reconstruction, including curbs, sidewalks, driveway approaches, and pavers.
- Broadway (E. Jones to Roy Smith).
   August 2023 through September 2023, CPS duct bank work continues. Two-way traffic northbound and southbound is open and will be maintained while work on the west side of Broadway occurs.
- Avenue B, McCullough, and N. Alamo.
   Bike lane work continues with installation of bike lane dividers.
- Broadway (Brooklyn to Pecan).
   Reconstruction work is planned to start as early as September 2023. Updates to be provided prior to construction.

Project Milestones / Completed Items: Lower Broadway:

- AT&T installations completed
- SAWS water completed
- SAWS sewer completed
- CPS network installation

Avenue B & North Alamo bike lanes:

- Traffic has been converted to a permanent southbound one-way traffic on Avenue B.
- Tree and landscaping completed.
- Signage completed.

Work is associated with the \$42 million, 2017 Bond Project. Businesses and residents have sidewalk and parking lot accessibility. Bike lane work is in association with the Avenue B/North Alamo bike lanes. Construction began July 2020 and will be substantially complete by Summer 2024. Residents were pleased to see lane striping and crosswalks applied in June to the freshly repaved portion of N. New Braunfels between Eleanor Avenue and Burr Road. Unfortunately, stripes for bike lanes on both sides of N. New Braunfels have not reappeared. When questioned about a timeline for bike lanes to be restriped, the City reported somewhat vaguely "The city is potentially redesigning those bike lanes and there is no estimated time." Efforts to learn details from the Transportation Dept. have been less than fruitful.

## SAN ANTONIO BOTANICAL GARDEN

One of San Antonio's premier institutions is right in our own backyard – the Botanical Garden is easy to enjoy in the summer as they open at 8am, and Wednesdays they remain open until 9pm. With a mission of "enriching lives through plants and nature," the BG welcomed nearly 300,000 visitors last year to enjoy their lovely grounds.

In addition to the return in November of the Lightscape extravaganza during the winter holiday season, their big exhibit called Imaginary Worlds: Once Upon a Time will be available through January. Created in Canada by Mosaiculture Internationales de Montreal, the display is "an intricate horticultural exhibition, featuring larger-than life botanical sculptures, bringing to life fantastical creatures and characters from dragons to mermaids."

For those who love numbers, here are a few. The City of San Antonio donated \$1.2 million last year to the Botanical Garden, slightly less than the income from Lightscape, which was \$1.5 million. The Botanical Garden has 11,000 members. The staff have responsibility for caring for acres of plants, including 42 endangered and rare plants. Sometime this year, or perhaps several times, plan to enjoy our backyard treasure, the SA Botanical Garden.
