BRACKENRIDGE PARK PROJECT APPROVED

San Antonio City Council approved awarding a \$3.5M construction contract last month for the first phase of the Brackenridge Park improvement project, which was part of the voter-approved 2017 bond package. The first phase will include repair of river retaining walls, stabilization of the pump house foundation, and reconstruction of a large staircase to the river. The project has drawn criticism for its plan to cut down 48 trees, including "heritage trees" with trunk diameters greater than 24".

The Brackenridge Park Conservancy is hosting Parktober Fest on Sunday afternoon, September 24 at the Koehler & Cypress Pavilions near the zoo entrance. This free event celebrates San Antonio's German biergarten heritage and will feature complimentary samples from local craft breweries, music by the Beethoven Mannerchor, and a collection of vintage Pearl Brewing Company memorabilia. ZONING CHANGE NOTICES, PART 1

When a property owner requests a zoning change or variance from the City's Unified Development Code or the Neighborhood Conservation District, the City mails a notice to owners of property within 200' of the subject property and the MPNA. The notice describes the proposed change and date of the hearing regarding the proposed change. The notice may include a map with subject property (sample below).



The notice will ask the addressee to respond "in favor" or "in opposition" to the proposed change. At the hearing regarding the proposed change, the number of responses in favor & in opposition will be announced and are considered as part of the commission/board's decisionmaking — so it is important to reply.

In response to the recent variance request at 115 Milton St. MPNA board member Susan Geery suggests notifying the MPNA (sometimes the City fails to do so). Also, go by the subject property, then talk to neighbors about their opinion of the proposed change. If you have questions, email the MPNA. An MPNA board member or Land Use Committee member may be able to explain consequences of proposed changes. Most importantly, REPLY, either by returning the notice or by phone, per directions in the notice.

ZONING CHANGE NOTICES, PART 2

Challenge. When City notices announcing proposed zoning changes are received by nearby property owners, there are only a few days in which to respond before the hearing date.

Solution. MPNA Board is forming an ad hoc team to be responsible for informing neighbors of zoning change notices. Team members will make sure nearby neighbors have received & understand notices. Goal is 2 volunteers per street to conduct outreach. If interested, please email the MPNA board at info@mahnckepark.org

Note. This is not a replacement for the Land Use Committee but an outreach team to help make sure notices are understood and hopefully returned.

ZONING BOARD OF ADJUSTMENT: 115 MILTON ST.

The application submitted by the property owner of 115 Milton Street to the City seeking multiple variances from the Mahncke Park Conservation District is "on pause." The case was set to be considered by the Zoning Board of Adjustment on August 7, but was pulled from the agenda. Nevertheless, construction continues the new three story, 2-unit structure located on the west side of Milton St. between Claremont Ave. and Natalen St.

In response to an email from the MPNA requesting status of the case, a City of San Antonio representative replied, "As of right now, the case is on pause, pending the decision of the applicant. The applicant informed me that they were in the process of altering plans, which may eliminate the need for the variances. If they are still required to obtain one with the altered plans, notices will be sent out and the process starts over again."
