### LOST DOG STORY WITH HAPPY ENDING

During last month's BIG FREEZE of four consecutive days under 20 degrees, concerned neighbors noticed a regal German Shepherd, seemingly lost and stoically weathering the conditions along Pershing Ave. and Old Austin Road. Good Samaritans left blankets, water and food along his route headquartered at the street intersection. The handsome dog spent most nights outside at that location. (He did locate a heat lamp in a garage on Pershing one night, but did not receive a "warm welcome" from the resident cats).

Two kind animal lovers were finally able to coax him into transport to a veterinary facility in Alamo Heights. There it was determined that his chip was not registered. His fate became more dire after two fostering attempts failed because of his destructive behavior (an animal behaviorist was even consulted). Happily, further sleuthing unearthed the original owner, who claimed Duke. He had been stolen a year earlier. Duke and his owner are happily reunited, and further destructive events have not been reported.

# OBSERVANT RESIDENTS KEY TO NEIGHBORHOOD

Driving and walking in our neighborhood yields interesting information. For instance, a neighbor noticed the beginning of what looked like a house demolition near her home. She contacted the City of San Antonio and was told that there were permits for foundation work and extensive remodeling, including the addition of a second story. Satisfied City staff had been notified, the neighbor went about her business. Other neighbors observed the foundation work being accomplished, which was fine since the house needed lots of work. Soon, however, the extent of the remodeling became obvious. The entire structure of the house was removed and only the foundation remained. This information was shared with the City and quickly a "stop work order" was issued. Evidently, the City's building inspector felt the owner/contractor moved "outside the scope of work" of the project for which permits had been issued.

What to take away from this? The City is willing to question work being done, but must know what is going on. Neighbors are responsible for ensuring that City staff knows what is happening in our neighborhood so that permits may be enforced. Generally all vertical construction or revisions to existing structures require a permit, so please ensure that appropriate permits for work on your home and property are obtained.

## WATCH FOR NEIGHBORHOOD CONSTRUCTION

Not sure what to watch for? The Neighborhood Conservation District guidelines are available at <u>https://www.sanantonio.gov/Portals/0/Files/Planning</u> <u>/NPUD/NCD6\_MahnckePark.pdf</u>. A brief summary of contruction to pay attention to includes curb cuts, garages and carports, fences, lighting, driveways, front walkways, new accessory structures, building height, and building setbacks – front, side, and rear.

In addition to the particular requirements of the NCD, virtually all construction requires a permit, including roofing and house levelling. The City's Development Services Dept. website is tolerably easy to work with in terms of getting a permit and staff at 210-207-1111 are helpful.

### YOUR TAX \$\$\$ AT WORK, PART 2,109,303,866.A

Observant neighbors have noticed the dedicated bike lanes on Broadway Street in the area north of Jones Avenue have been removed. There are now three traffic lanes – both north & southbound - with right lanes that include bike images welcoming cyclists to share space with VIA buses and all other vehicular traffic.

## MEET MPNA BOARD MEMBER GREG TURNER

### YOUR TAX \$\$\$ AT WORK, PART 2,109,303,866.B

Neighbors once hoped for the prompt return of bike lanes on N. New Braunfels Avenue between Eleanor Avenue and Burr Road. The bike lanes disappeared in April when N. New Braunfels was resurfaced. And while Public Works Dept. replaced crosswalks and center lane striping in June, the stripes defining bike lanes on both sides of the street remain absent.

Throughout summer and autumn, Public Works Dept. reported reinstallation of bike lane striping was contingent upon design approval from the Traffic Dept. Finally in January, Public Works Dept. stated what they hoped was their final design revision had been submitted to the Transportation Dept. and "if everything goes well" reinstallation of bike lane striping could "get started in early March if not before."
